

## **Expression of Interest**

The Enhancing Wellbeing through Beauty Care (EWTBC) project aims at developing further soft skills course for hairdressers, beauty therapists, nail technicians and other related professions within the beauty sector. This EUFunded aims at developing two modules in the following two areas:

- 1. Understanding Mental Health Difficulties of Clients.
- 2. Basic Helping Skills for Professionals within the Beauty Sector.

The first step following the writing and development of the course, is to conduct and deliver the proposed course as a pilot programme. Eventually the course will be online and will be available free to all the professionals in the beauty sector.

With the aim to have the best content before accrediting and developing the course, we are inviting 3 participants from each country, if possible coming from different professions (that is one hairdresser, one beauty therapist and one as nail technician or other related profession) to contribute to these courses by participating for a 5 day-training in Malta between the **Monday**, 6<sup>th</sup> **November and Friday 10<sup>th</sup> November 2023**. All the expenses for flights, lodging and subsistence shall be paid through the project.

Applicants have to satisfy at least the following 5 criteria, however if there are not enough participants the Selection Board might also accept other participants who do not satisfy these criteria:

- 1. 2 years experience in the profession (hairdresser, beauty therapist, nail technician or related profession) (5 points)
- 2. Did not participate in any other EU-Funded similar to this project (5 points)
- 3. Different professions (the preference would be that the 3 participants come from three different professions) (5 points)
- 4. Participants come from different Businesses (5 points)
- 5. Knowledge of English language (at least B2 self-declaration) (5 points)
- 6. Special Consideration for "people with fewer opportunities" will be taken (5 points):
  - o Disability
  - Age 50years+
  - Has been unemployed during these last two calendar years
  - Has just finished training from your institution
  - o Has been doing badly in business (needs to provide accounts of the previous 2 years) (5 points)

## **Selection Criteria**

Since 3 participants need to be chosen from three (3) different categories, 1 from each category, the first step in the selection process will be that of dividing the applications according to category and the participants will be chosen according to the category.

- 1. Persons with the highest points from every different profession will be chosen.
- 2. If participants have the same points, then they will be chosen according to the date of application.





- Erasmus+
  - 3. If there are not enough participants from one category or another to be chosen, then first preference will be given to the persons who are within the same category and do not satisfy all criteria.
  - 4. If there are no participants in one category or another then, the participants are chosen from another category first according to the highest points and then according to the date of application.

With the application, a copy of the CV and the ID Card need to be uploaded. If you are not able to upload it, then send them to the person who has sent you the Expression of Interest.
